

# Mubea U-Mobility Raffle: 10x2 DISCOVERY PASS tickets for the GREENTECH FESTIVAL in Berlin for the world premiere of the XBoard

# Terms of participation:

Muhr und Bender KG, Mubea-Platz 1, 57439 Attendorn (hereinafter referred to as: "Mubea U-Mobility") is holding a raffle where 10 people throughout Germany can each win 2 DISCOVERY PASS tickets (a total of 10x2 tickets) for the GREENTECH FESTIVAL in Berlin to be used on 15/06 or 16/06/2023, worth a maximum of 19 EUR per ticket. The GREENTECH FESTIVAL will be where the world premiere of the XBoard will take place. Attention is drawn to the raffle via the Instagram account of Mubea U-Mobility (https://www.instagram.com/xboard\_umobility/).

In order to ensure optimal readability, the simultaneous use of female and male forms of expression has been dispensed with in these terms and conditions of action. In these Terms of Action, the masculine form of speech or the generic masculine are used. In any case, however, all persons are addressed equally.

The tickets will be sent digitally by e-mail after the end of the raffle.

# Participation:

Participation in the raffle is free of charge. A participant can enter the raffle by following the Instagram account of the Mubea U-Mobility XBoard (<u>https://www.instagram.com/xboard\_umobility/</u>) and by liking the raffle post on Instagram. The participation in the raffle is possible from 02/06/23 until 08/06/23, 17 clock (closing date). The participant assures that all information provided by him/her is true.

# Eligible participants:

People who are German residents and are over the age of 14 are eligible to participate. Participation is not restricted to customers of Mubea U-Mobility and is not dependent on the purchase of goods or services. If a participant is limited in his or her legal capacity, the consent of his or her legal representative is required. Participation is also possible for employees of the Mubea group of companies.

#### Winner determination:

The Mubea U-Mobility marketing department will randomly select 10 winners from the entries received after the closing date, at the latest on 12/06/23 and these winners will the people receiving the prize will be determined afterwards (2 DISCOVERY PASS tickets for one day on 15/06 or 16/06). At any time, Mubea U-Mobility has the possibility to check submitted entries. Multiple entries by the same participant are prohibited. Failure to do so may result in a disadvantage for the participant concerned (exclusion from the raffle).



#### Winner Announcement:

The winners will be informed about the prize via a private message in a timely manner after the conclusion of the raffle. Thereafter, the winners will contact Mubea U-Mobility via private message for the purpose of transmitting the email address. If the winners do not get back to us with their email address within 24 hours, they will forfeit their claim to the prize. For data protection reasons, we ask participants not to leave addresses on the pinboard or as a public comment.

A transfer and a cash payment of the prize are not possible.

#### Termination of the raffle:

Mubea U-Mobility expressly reserves the right to cancel or change the design of the raffle without prior notice and without giving reasons. This applies in particular to any reasons that disrupt or prevent the sweepstakes from running as planned, or if correct implementation is not possible for technical reasons or, for example, due to legal restrictions.

#### Applicable law:

The raffle is governed exclusively by the laws of the Federal Republic of Germany. Legal recourse is excluded.

The legal basis for the processing is Art. 6 para. 1 lit. f) DSGVO.
