

## Mubea U-Mobility Competition: Win signed balance board from Coda, JannisZ and Johanne Defay

### Conditions of participation:

Muhr und Bender KG, Mubea-Platz 1, 57439 Attendorn (in the following "Mubea U-Mobility") is holding a competition in which one person can win a XBoard branded balance board from DaffyBoards which was signed by Coda, JannisZ and Johanne Defay. The competition will be advertised via all Mubea U-Mobility social media channels.

To ensure optimum clarity, the present terms and conditions of action use neither male nor female forms of expression. In these terms and conditions of action, the masculine form of speech or the generic masculine is used. In any case, however, everyone is addressed equally.

### Participation:

Participation in the competition is free of charge. A participant enters the contest by registering for the Mubea U-Mobility XBoard newsletter (<https://xboard.mubea-umobility.com/en/xboard/community>). Participation in the competition is possible from 28.09.23 to 12.10.23. The participant should guarantee that all information provided by him is true and correct.

### Eligible participants:

German residents who have reached the age of 14 are eligible to participate in this competition. Participation is not limited to customers of Mubea U-Mobility and is not dependent on the purchase of a product or service. If a participant has limited legal capacity, the consent of his legal representative is required. Participation is also possible for employees of the Mubea group of companies.

### Winner determination:

After the end date, the Mubea U-Mobility marketing department will randomly select one winner from the entries received. Mubea U-Mobility has the possibility to check submitted entries at any time. Multiple entries from the same participant are not allowed. In case of non-compliance, this may result in a penalty for the participant concerned (exclusion from the competition).

### Winner announcement:

The winner will be informed of the prize promptly by e-mail after the competition is closed. After that, the winner will contact Mubea U-Mobility by e-mail to send his address. If the winner does not get back to us with his respective address within 24 hours, the claim to the prize will be forfeited. For data protection reasons, we ask participants not to leave addresses on the pinboard or as a public comment.

A transfer or cash payment of the prize is not possible.

After the announcement, the signed balance board will be sent to the winner by post.

## Termination of the competition:

Mubea U-Mobility expressly reserves the right to cancel or change the design of the competition without prior notice and without giving reasons. This applies in particular to any reasons that disrupt or prevent the competition from running as planned or if running the competition correctly is impossible for technical reasons or, for example, due to legal restrictions.

## Applicable law:

The competition is subject exclusively to the laws of the Federal Republic of Germany. The legal process is excluded.

## Privacy Policy:

Your personal data will be processed by Muhr und Bender KG, Mubea-Platz 1, 57439 Attendorn, as the responsible body, for the duration of the competition for the purpose of determining and processing the prize on the basis of the above conditions.

The legal basis for the processing is Art. 6 para. 1 lit. f) DSGVO.

Your data will only be stored until the prize is determined and processed and then destroyed in accordance with data protection regulations.

The right to publish the winners is obtained by written consent. You have the possibility at any time to request information about the stored data, to have the stored data changed or deleted.
